I am writing you to draw your attention towards the violation of the IMS Act (http://wcd.nic.in/infantmilkpact1.pdf; http://wcd.nic.in/IMSamendact2003.pdf) being committed by your online shopping portal Flipkart.com by advertising and providing rebate on sale of the feeding bottles (http://www.flipkart.com/store/baby-care/feedingnursing/bottles-accessories/products?layout=grid).

IMS Act is a law to protect, promote and support breastfeeding in our country. It prohibits advertising of feeding bottles by any means. The IMS Act also prohibits providing incentives to the buyer for increasing the sale of feeding bottles.

Breastfeeding Promotion Network of India is a registered voluntary organisation which has been gazetted by government of India to monitor and report violations of IMS Act (http://wcd.nic.in/cw/GOI3.pdf).

We request you to kindly withdraw advertisements of all kind of feeding bottles and nipples etc. to abide by the provisions of the IMS Act.
