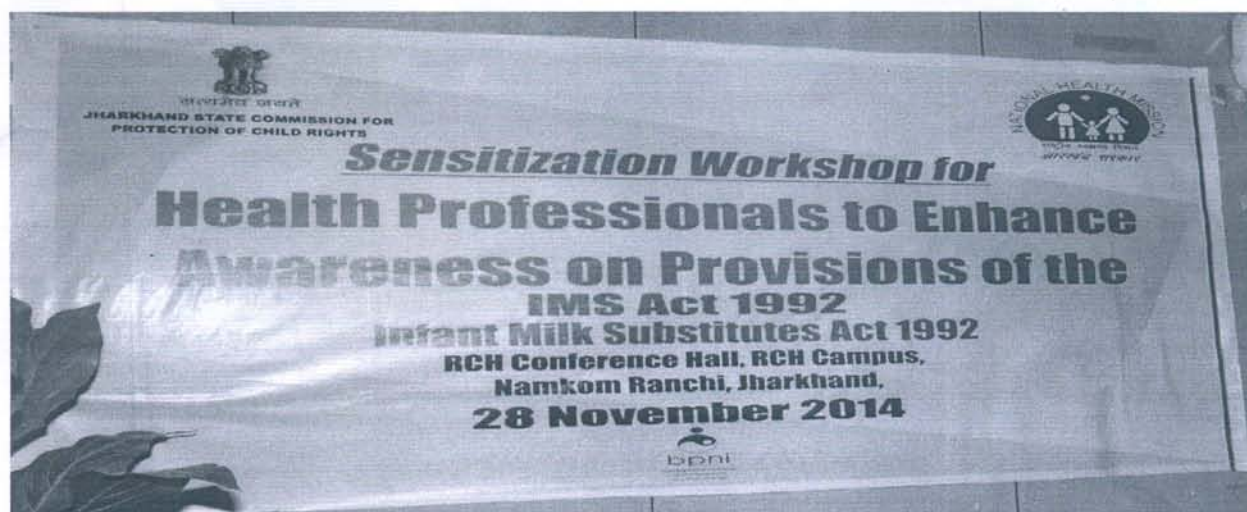


**Sensitization workshop for Health professional to enhance awareness

A one day sensitization workshop for 'Health professional to enhance awareness on provision of the IMS Act, 1992' was organized by National Health Mission, Jharkhand State Commission for Protection of Child Rights and Breastfeeding Promotion Network of India on 28th November 2014 at RCH conference Hall, RCH Campus, Namkom, Ranchi.

Dr. Arun Gupta put the context of the necessity of Breast feeding as well as how Infant milk Substitute companies insidiously undercare the confidence of mothers in their ability to breast feed.
